# The Sunset of the Federal Estate & Gift Tax Exemption **Transfer Taxes**

### Overview

- Estate Tax
- Gift Tax
- The 3<sup>rd</sup> Tax (Generation Skipping Transfer Tax)
- What is an "estate"?
- Rate: ~40%

### **Exceptions & Exclusions**

- Annual Exclusion: \$18,000 to any person per year.
- Unlimited Marital Deduction: Individuals may make transfers to spouses (U.S. citizens).
- Gifts to Charity: Any gift during life to a qualified charity/501(c)(3) is exempt from gift tax.
- Lifetime Unified Gift & Estate Tax Exemption Amount: \$13,610,000.

## The Sunset of the Federal Estate & Gift Tax Exemption Upcoming Tax Law Changes

#### Example

- A married couple can transfer \$27,220,000 (\$13,610,000 per individual) free of federal gift & estate taxes should they implement a gifting strategy prior to January 1, 2026.
- The same married couple could lose their ability to transfer approximately half of the above amounts if they don't act prior to the Tax Cuts & Jobs Act's expiration.
- In addition, it's exponentially beneficial to remove any subsequent growth on those assets from their estate.
- The below graph shows the difference in estate taxes for a family with \$50,000,000 of net worth as of today, & as of 2026.




